### What you need to do

#### 1 Complete this application form

First time applicants will also need to complete a firearms safety course as outlined in the 'Arms Code'.

Licence renewal applicants will also need to complete the multiple choice safety test on the back of this form.

#### 2 Attach your application fee receipt

Fees are payable at a PostShop, fees can be obtained by contacting your nearest Police Station or online at: www.police.govt.nz/advice/firearms-and-safety/firearms-offices-and-contact-details

#### 3 Provide two recent colour passport photos

#### 4 Deliver your application to Police



# What happens once we have your application ...

- A background check will be carried out.
- A vetting officer will contact the applicant to arrange an interview and complete a security check.
- A vetting officer will interview the applicants referees.

#### What else you need to do ...

- You will need to have a good understanding of the 'Arms Code' and what is required of you to use a firearm.
- You will need to provide a safe and secure place to store your firearms (see the 'Arms Code').



#### The 'Arms Code' forms the basis of the Firearms Safety Test which must be sat by all firearms licence applicants.
